 - II. **Nominal Rolls (One Copy):** Prepare the nominal rolls batch - wise and Hall Ticket number wise and submit the copy with EAF forms. The examination application forms submitted by the Principal/Directors should tally with the nominal rolls. Any name without application cannot be considered.
6. Instruct the students to enclose the Xerox copies of Memorandum of marks of earlier Examination.
 7. Application forms with all the above requirements should reach the Examination Branch, O.U on or before **22nd January, 2018** . If EAF is prepared after **22-01-2018** a late will be imposed.
 8. NOTE: As per Notification, not eligible students numbers will be deleted/removed from result process at any time, if Hall ticket issued.
