- The College login will be closed after the last date.
- Principals are requested not to forward/submit the EAF of Not Eligible Candidates. The results of Not Eligible candidates will be cancelled at any stage, if they write the examination.

### **NOTE:-**

- 1 The Students are advised to enclose Xerox copies of their qualifying examination Certificates attested by the College Principal's concerned with the examination application forms and Migration Certificates if any with Migration Fee of Rs. 150/- ( If the candidate belongs to other than O.U. )
- 2 In respect of I Semester (CBCS) Fresh Admissions the Colleges have to get clearance letter from the Director, Academic Audit Cell, O.U. and the Examination Application Forms of I Sem.(CBCS) students during the Academic year 2017-18 are to be submitted online through College login. Also hard copy of the same may be downloaded and submitted to the Examination Branch duly signed by the students and Principal concern along with photocopy of qualifying Certificate.

3. The Principal is requested to send the **Faculty list** without which the examination forms will not be accepted.
4. The Principal is requested to verify the eligibility of the students thoroughly and forward the same to this office for the issue of Hall Ticket. If failed to verify the eligibility of the candidates, the principal is held responsible for the issue of hall ticket by this office to the non-eligible candidates.
5. The Principal may kindly forward all the examination application forms along with the prescribed examination fee on or before **08-01-2018** together with Nominal Rolls
6. The Colleges maintaining their account with the branches of State Bank of India (SBI) OR any other bank are required to deposit the consolidated amount in any branch of SBI for Credit into "**Registrar, Examination Fee Fund A/c No.52198262033**" and can obtain a receipt from the bank and submit the same to the Examination Branch along with Examination forms on or before **08-01-2018**.
7. As a part of the Core Banking System, all the students are hereby instructed to deposit the Examination Fee into their respective college accounts only for onward transmission to the University by the college.

***Not to collect the Exam fee form Blind, Physically Disabled Deaf & Dumb students as per O.U. Order No. 1555/228/2007-08 /Budget-V, dated: 25-03-2008. A Xerox copy of medical Certificate confirming their status as Handicapped (minimum percentage of disability must be of 40% attached to the application forms. Blind, Physically Disabled, Deaf & Dumb students applications forms should be submitted separately along with separate Nominal Roll.***

8. Any discrepancies with regards to the Candidate data such as Internal marks, Practical, Viva-voce and Projects etc. should be brought to the notice of concerned officials of Examination Branch and obtain the acknowledgement within one month of declaration of results. After one month, queries will not be entertained.
